RECOMMENDED STORAGE AND HANDLING: RELIOBOND 705 adhesive should not be stored at less than 40 °F. Once it has been frozen, it cannot be returned to its original state. No special precautions are necessary for handling RELIOBOND 705 adhesive. For further health and safety information, refer to Material Safety Data sheets.

USE CONDITIONS: On porous or semi-porous surfaces, such as chipboard, plywood and hardboard, RELIOBOND 705 adhesive should be applied to the surface and the bond should be accomplished within 30 seconds after adhesive application. For optimum results, approximately 10 psi pressure should be applied to the bond to insure good contact.

RELIOBOND 705 adhesive can be applied satisfactorily with a brush, knife coater, roll coater or spray gun. Clean up can be accomplished with water when still wet of with toluene when dry.
